Wellness Program for Inside Members

Inside members and spouses have to fully complete the questionnaire and check-up for the Wellness Program by November 30, 2017. **Don't procrastinate**. Inside members have to do two things in order to earn \$250 on a Benny card and avoid an increased deductible for your health insurance. Complete the online Health Questionnaire at **www.moverewellness.com**. When prompted for Location Code use "IBEW", when prompted for Security Code use "HMCMOVERE". Then complete a screening with your physician. Once you have your results either type the results into the online Health Questionnaire or send by November 30, 2017 to HMC Movere to be uploaded to your wellness account:

If Inside members, or their spouses, choose NOT to participate then the deductible will go from \$100 to \$500 per person in 2018. For example, if my wife decides not to complete a health screening, then even though I did it and received the \$250, our family deductible will go from \$400 for the four of us to \$2,000 starting in 2018. For now the increase will only last for one year. There will be another opportunity to complete the questionnaire and screening for 2019.

At the last H&W meeting the Board took action to further define the Wellness Program currently underway for Inside members. Any new Inside members becoming eligible on or after October 1, 2017 will have until September 30, 2018 to complete the questionnaire and screening, and receive the \$250 in their HRA (applicable to both member and spouse). If they choose not to comply by September 30, 2018, their deductible will increase from \$100 to \$500 per family member on January 1, 2019. The increased deductible is currently only for one year: effective in 2018 or 2019. There will be another opportunity to come into compliance in 2018 for the year 2019. If members, and applicable spouses, complete the questionnaire and screening by September 30, 2018, then in 2019 they will have the lower deductible. Otherwise if they don't comply again, they will have another year of the higher deductible.

This Month in Labor History

- **2 June 1924** A child labor amendment to the U.S. Constitution was proposed; only 28 of the necessary 36 states ever ratified it.
- **3 June 1918** A Federal child labor law, enacted two years earlier, was declared unconstitutional. A new law was enacted 24 February 1919, but this one too was declared unconstitutional on 15 May 1922.
- **8 June 1904** A battle between the Colorado Militia and striking miners at Dunnville ended with six union members dead and 15 taken prisoner. Seventy-nine of the strikers were deported to Kansas two days later.
- **10 June 1963** Congress passes a law mandating equal pay to women.
- **11 June 1913** Police shot three maritime workers (one of whom was killed) who were striking against the United Fruit Company in New Orleans.
- **14 June 1924** A San Pedro, California IWW hall was raided; a number of children were scalded when the hall was demolished.
- **20 June 1947** The Taft-Hartley Labor Act, curbing strikes, was vetoed by President Truman. Congress overrode the veto.
- **20 June 1941** Henry Ford recognizes the UAW.
- **21 June 1877** Ten coal-mining activists ("Molly Maguires") were hanged in Pennsylvania.
- **22 June 1922** Violence erupted during a coal-mine strike at Herrin, Illinois. Thirty-six were killed, 21 of them non-union miners.
- **25 June 1938** The Wages and Hours (later Fair Labor Standards) Act is passed, banning child labor and setting the 40-hour work week. The Act went into effect in October 1940 and was upheld in the Supreme Court on 3 February 1941.

Jebediah Novak is a third generation Wireman with IBEW Local 405, Cedar Rapids, Iowa City and an instructor with the Cedar Rapids Electrical JATC.

Where we have a pre-existing knockout in an enclosure and we need to increase the size of the knockout to accommodate for a larger sized conduit, however we don't have the ideal tool, which would be a knockout punch. Instead, we are going to have to use a hole saw.

What we can do is lay out where we want our new hole to go, get a piece of scrap 2×4 and pre-drill a hole using your hole saw to fit the size conduit that we are going with. Then, lock the backside with a piece of wood, that gives out pilot bit something to go into. Then we will line up our template. You may want to put a couple lines in there to keep an eye on where you are at. Grab a clamp and clamp the piece of wood into position. My 2×4 will act as a guide to allow me to drill my knockout. Now, we are ready to accommodate our two-inch conduit.

Hopefully this job tip will help you on the job site and make your next installation a little easier.

Mike Holt NEC Question and Answer

What are the working space and access requirements in the Code for equipment located above suspended ceilings or in a crawl space?

- A4. Where equipment operating at 1000V or less is likely to require examination, adjustment, servicing, or maintenance while energized is located in a space with limited access, all of the following conditions apply [110.26(A)(4)]:
- (a) Equipment installed above a suspended ceiling must have an access opening not smaller than 22 in. x 22 in. Equipment installed in a crawl space must have an accessible opening not smaller than 22 in. x 30 in.
- (b) The width of the working space must be a minimum of 30 in., but in no case less than the width of the equipment.
- (c) The working space must permit equipment doors to open 90 degrees.
- (d) The working space in front of the equipment must comply with the depth requirements of Table 110.26(A)(1), the height is what is necessary to install the equipment. Horizontal ceiling structural members are permitted in this space.

Brother **Helmut "Carl" Buse** passed in April 2017. He was a 60-year member.


Save the Date


