THE HEALTH CORNER

IMPORTANCE OF A HEALTHY MOUTH

Good dental hygiene is important for your overall health. When teeth and gums are healthy, the bloodstream is protected from the bacteria and germs that hang out in our mouths. However, dental problems like gum disease and tooth decay can make it easy for bacteria to enter your bloodstream contributing to many health conditions such as: heart disease, pneumonia, Alzheimer's, periodontal disease (destroys jaw bone and can cause loss of teeth), diabetes, high risk pregnancy/premature birth, sleep apnea, arthritis, and cancer, to name a few.

To protect your oral health, take care of your mouth every day:

- See a dentist/dental hygienist twice a year for checkups and cleaning (member benefit).
- Brush your teeth at least twice a day. Using electric toothbrushes has shown to be beneficial.
- Floss daily 2x/day if possible. Food particles can lodge between your teeth and cause bacteria to buildup.
- Replace your toothbrush every 3 to 4 months. Do it sooner if bristles are worn or flare out._____
- Eat a healthy diet and limit sugary food and drink, and don't use tobacco.
- Contact your dentist if you have any dental problems, pain, cold/hot sensitivities to food/drinks.

We will be moving into summer in the next couple of months and there will be more heating up than the temperature.

We did fairly well in the Primary but lost all the Santa Cruz City seats we endorsed as the Business community put on a strong effort to protect their interests. In order to establish a better political base we will look at starting a grass roots organization with Sant Cruz residents to strengthen our efforts there.

The most disappointing of the races occurred in San Benito County where incumbent Bea Gonzalez, who we supported, lost 1161 to 875. The most powerful seat in County government and all the winner had to get was 1161 votes. This is unheard of, but it happened, and we need to come up with a strategy in that County which will produce better results.

The good news is we did very well in the National and State races as Jimmy Panetta and Zoe Lofgren will move on in their Congressional races, John Laird is moving on in the State Senate race, and Dawn Addis, Gail Pellerin, and Robert Rivas are virtual shoe-ins in their State Assembly races.

We also did well in the Supervisor races in both Monterey and Santa Cruz Counties. Luis Alejo and Wendy Root- Askew easily won and we welcome Kate Daniels as our new 5th District Supervisor. In Santa Cruz County we lost the 1st district race as the incumbent Manu Koenig beat out Lani Faulkner who we supported. But Monica Martinez almost won and will be in a runoff in the 6th District along with two candidates we supported in the 2nd District race, Kristen Brown and Kim De Serpa.

Within the jurisdiction of Local 234 we have over 24 City and County governments, around 40 School Districts, and numerous Special Districts and other agencies which all have the power to decide on Capital Projects which we may work on. This does not include the Federal and State agencies in our area. The point here is, we not only need to maintain a presence within our area but be a force to deal with and cooperate with for the betterment of our communities and area.

One day, we shall look like this as we exhibit our strength and commitment to making lives better for working people. Let's all work together toward building that strength.

Ratified: New Wage Increases and Contractual Changes

We're thrilled to announce the ratification of our successful negotiations at our recent Union meeting. This achievement marks a significant milestone for our members and reaffirms our commitment to their well-being and prosperity. With determination and dedicated leadership from myself and Jorge Suarez, along with the opportunity to collaborate with our NECA counterparts, we've reached favorable terms that reflect our shared values and priorities. As always, thank you for your unwavering support and participation in shaping the future of our Union. Together, we will continue to advocate for the best interests of our members and build a stronger, more prosperous community.

The following is a summary of the key wage increases and contractual changes that have been ratified:

Article l, Section 1.01

- Three year agreement beginning June 1, 2024 through May 31, 2027.

Article III, Section 3.04 - Wages

-Pay increase negotiated:

\$4.65	\$4.65	\$4.70
12-2024	12-2025	12-2026

Article III, Section 3.06 - Pay Day

-Add to second paragraph, "if the employee fails to provide a correct timecard, the employer will process the pay to the best of their ability and correction is required by the employee as quickly as possible."

Article Ill, Section 3.08 - General Provisions (d)

-Eliminate Overtime Preference Language.

Article Ill, Show up Pay (c)

-Change language to eliminate show up pay for any applicant for employment.

Article III, Section 3.26 (c)

-Modify language to read "On all energized circuits carrying foru hundred and forty (440 volts) or over, as a safety measure, two (2) or more properly trained individuals must work together, one (1) standing by, both wearing PPE.

Article Ill, Section 3.28 - Tunnel Work

-Clarify language for heading and benching for the beginning of work in tunnels to read as follows:

"In the context of tunnels, the head isn't a physical part of the structure its self, but rather refers to the leading excavation phase. This is the area where the tunnel boring machine (TBM) or construction crew is actively digging and removing earth or rock."

Article V, Section 5.12 – Apprentice Ratio

-Each job site shall be allowed a ratio of two (2) apprentices for every one (1) Journeyman wireman.


Article Ill, Section 3.19 Tool list

-Reduction of Required Tools: The following will be removed from the tool list:

Awl, 6 foot ruler, plumb bob, hack saw frame and tin snips. Cost of replacing hand tools will be adjusted from \$1,145.00 to \$1,060.00
